Call to Order

Chairman, Tim McIntire called the meeting to order at 9:32 AM. The PT Section and staff present gave brief introductions to the OSU DPT class.

Approval of Minutes

CJ Miller moved that the PT Section authorize that the Executive Director or Agency Designee to accept or reject consent agreements on the Section's behalf for the period beginning September 15, 2022 and ending September 30, 2023. Erin Hofmeyer seconded. All in favor. Motion passed.

CJ Miller moved that the PT Section authorize the use of signature stamps or electronic signatures by the Section Chairperson, Section Secretary, Executive Director, or Agency Designee for the period beginning September 15, 2022 and ending September 30, 2023. Seconded by Erin Hofmeyer. All in favor. Motion passed.

CJ Miller moved that the PT Section authorize the Executive Director or Agency Designee to make editorial changes to motions for the period beginning September 15, 2022 and ending September 30, 2023. Erin Hofmeyer seconded the motion. All in favor. Motion passed.

CJ Miller moved that the PT Section authorize the use of hearing officers for the period beginning September 15, 2022 and ending September 30, 2023. Erin Hofmeyer seconded. All in favor. Motion passed.

CJ Miller moved that the PT Section authorize the staff to issue licenses to applicant with completed applications and that the Section ratify the licenses issued by the staff at the Section meeting following the issuance of the license for the period beginning September 15, 2022 and ending September 30, 2023. Seconded by Erin Hofmeyer. All in favor motion passed.

Discussion of Law and Rule Changes

CJ Miller moved to authorize the Executive Director to file rules related to the Safe Haven Program with the Joint Committee on Agency Rule Review, pending recommendation from the Common Sense Initiative. Karen McIntyre seconded the motion. All in favor. Motion carried.

CJ Miller moved to authorize the Executive Director to file rules related to the option for a TOEFL waiver for endorsement applicants with certain qualifications with the Common Sense Initiative. Erin Hofmeyer seconded. All in favor. Motion passed.

Karen McIntyre moved that the executive director file language related to allow PTAs to teach in academic programs. Erin Hofmeyer seconded. All in favor. Motion carried.

Mario Baker moved to amend the licensure language for internationally educated applicants to have their education equivalence assessed based on the applicants' graduation year. Karen McIntyre seconded. All in favor. Motion carried.

Licensure Applications

Mario Baker recommended a motion be made to accept the findings regarding applicant APP-000611070 from the FCCPT Credential Evaluation that the individual's education is not equivalent to the first professional degree in physical therapy in the United States, based on the documentation provided, for PT endorsement application and deny the TOEFL waiver request due to the lack of statutory authority. Tony Ganim made the motion and CJ Miller seconded. Karen McIntyre and Mario Baker abstained. All in favor. Motion carried.

Mario Baker recommended a motion be made to accept the findings from the FCCPT Credential Evaluation regarding application APP-000610267 education is substantially equivalent to the first professional degree in physical therapy in the United States, based on the documentation provided, for PT endorsement application. Tony Ganim moved, and CJ Miller seconded. Karen McIntyre and Mario Baker abstained. All in favor. Motion carried.

Karen McIntyre moved that the Physical Therapy Section ratify, as submitted, the physical therapist and physical therapist assistant licenses issued by examination, endorsement and reinstatement by the Ohio Occupational Therapy, Physical Therapy, and Athletic Trainers Board from July 21, 2022 to September 15, 2022, taking into account those licenses subject to discipline, surrender, or non-renewal. 


If there is no further business and there is no objection, the meeting will be adjourned. There being no objection, Tim McIntire adjourned the meeting at 12:56 PM.
